Betreft: "De 9/11 tapes"

Geachte Redactie,

Naar aanleiding van Uw uitzending jongstleden dd. 19 augustus 2006, newsitem "De 9/11 tapes" wil ik hierbij reageren. U stelt dat :

"Deze week werden opnames openbaar van de luchtverkeersleiders die op de ochtend van 11 september 2001 dienst hadden. Bovendien werden in een diepe lade nog wat telefoon gesprekken met de alarmcentrale teruggevonden."

Dat is niet helemaal waar, want het Amerikaanse tijdschrift Vanity Fair publiceerde de Norad Tapes al op 3 augustus 2006, maar dat terzijde. Het artikel is ook online te vinden waar men de audio stukjes kan afspelen :

Het is inderdaad waar dat NORAD op de ochtend van de 11e september 2001 geen goede indruk maakte. Waar het hier in dit geval om gaat is dat Uw verslaggever Henk van de Aa geen melding maakt van het feit dat NORAD op die ochtend amper militaire vliegtuigen vanaf Andrews Air force base tot haar beschikking had. Deze waren, uitgezonderd een enkel toestel, allen op oefening elders. Verder is het zeer noemenswaardig om te vermelden dat een Journalist genaamd Christopher Bollyn, van American Free Press een heel ander verhaal op het spoor kwam :

American Free Press, has investigated the weird security practices of airbases and airports in the North East area, after he found out that NORAD was told to stay down [2].

Bollyn reports about how the Port Authority of former Stuart Airforce Base (only 60 miles north of the WTC Buildings) became a privately run and owned operation in the year 2000. Stuart Airforce Base is today known as Stuart International Airport and is currently the only privately owned Airport inside the United States. The current owner is a british company, which has its base in Houston, Texas.

The privatization of the Port Authority of Stuart Airforce Base and the WTC buildings was overseen and directed by Ronald Lauder, a son of Estee Lauder, the cosmetics company based in New York. He was the director of the government privatization board and pushed this agenda. Louis Eisenberg was in charge of the Port Authority of New York and New Jersey at that time. He also oversaw the lease negotiations, and managed to have Larry Silverstein get his lease deal on the WTC buildings 1., 2. and 7. on July 26, 2001.

Near Stuart Airbase is Boston Logan Airport which reportedly had a total lack of security during the twin tower attacks. The Security of Boston Logan Airport was run by Hunt Lee US Corp., a whole subsidiary of ICTS (International Consultants on Targeted Security) based in Amsterdam (<http://www.ictseurope.com/>), ICTS however turns out to be a 100% Mossad operation, as was claimed by Bollyn."

Dit is nog maar 1 kant van de zaak. Wat veel ingrijpender was is dat de Ptech software waarmee NORAD draaide, gecompromiteerd was door de Mossad en Israëlische software bedrijfjes. Op de ochtend van 11 september 2001 werden namelijk vanuit een commando bunker veelvuldig valse meldingen en vliegtuigen gesimuleerd, zodat de militaire staff aldaar volkomen dol gedraaid werden. Wat nog dramatischer is dat mensen betrokken bij deze zaak getuigen verklaringen hebben afgelegd dat Vice President Dick Cheney in deze bunker zat, om de NORAD software in de warte brengen met valse meldingen.

Een overzichts verhaal over Ptech en 911 wat doorspekt is met pointers naar de zogenaamde "Muslim Brotherhood" is gepubliceerd op een toonaangevende website From The Wilderness (FTW) [4][5].

Formeel genomen is Ptech is een startup bedrijfje gesticht in 1994 door een Libanese Moslim immigrant, Oussama Ziade die in 1985 naar de USA kwam [5]. Een nader onderzoek naar dit bedrijfje Ptech laat echter zien dat er wel degelijk een verborgen connectie is naar de Israëlische MOSSAD [6][7]. De journalist in kwestie heeft helaas moeten onderduiken na een vreemde arrestatie door de "undercover" politie [10].

Naast de rol van de Ptech software tijdens 911 is het noemenswaardig om te vermelden dat op 11 september 2001 zo'n beetje elke fighterjet in Noord Oost Amerika op oefening was, en zoals nu blijkt op de plek des onheils, Manhatten en Washington amper militaire fighter jets aanwezig waren :

"As it turns out, on September 11th, various agencies including NORAD, the FAA, The Canadian Air Force, The National Reconnaissance Office, and possibly the Pentagon were conducting as many as five wargame drills -- in some cases involving hijacked airliners; in

some cases also involving blips deliberately inserted on FAA and military radar screens which were present during (at least) the first attacks; and which in some cases had pulled significant fighter resources away from the northeast US on September 11. In addition, a close reading of key news stories published in the spring of 2004 revealed for the first time that some of these drills were "live-fly" exercises where actual aircraft were simulating the behavior of hijacked airliners in real life; all of this as the real attacks began. The fact that these exercises had never been systematically and thoroughly explored in the mainstream press, or publicly by Congress, or at least publicly in any detail by the so-called Independent 9/11 Commission made me think that they might be the Grail.

That's exactly what they turned out to be."

"That Vigilant Guardian had a direct impact on the Northeast Air Defense Sector in which all four hijackings occurred was confirmed in a December 2003 original story by NJ.com, a New Jersey-based service also summarizing all major stories published by New Jersey press outlets.

NORAD also has confirmed it was running two mock drills on September 11 at various radar sites and command centers in the United States and Canada, including air force bases in upstate New York, Florida, Washington and Alaska. One drill, Operation Vigilant Guardian, began a week before September 11 and reflected a cold war mind-set: Participants practiced for an attack across the North Pole by Russian forces{9}.

The story never named the second drill, and the assertion that it was strictly a cold war-type exercise is belied by direct statements of the principals involved that day. The NJ.com story also raised another chilling issue.

Investigators at the September 11 commission confirm they are investigating whether NORAD's attention was drawn in one direction -- toward the North Pole -- while the hijackings came from an entirely different region{10}.

Concluderend wil ik hierbij toevoegen dat het erg goedkoop is om het militaire personeel van NORAD alle schuld in de schoenen te schuiven. De aanval op het WTC op 11 September 2001, is geen simpele operatie geweest, die al zeker niet door een figuur als Osama Bin Laden vanuit een grot in Afghanistan kan zijn uitgevoerd. In tegendeel, 911 is een complot wat al begonnen is ten tijde van President Clinton, toen deputy White House counsel Vince Foster lanceerde codes van US Missiles doorspeelde aan de Israëlische Mossad [9].
